## **PRIVACY ACT STATEMENT**

**Authorities:** National Security Act of 1947, as amended; Intelligence Reform and Terrorism Prevention Act of 2004, as amended; Security Clearance Information Act of 1985, as amended; Security Clearance Reform Act of 2014; National Insider Threat Policy; EO 12968, Access to Classified Information, as amended; EO 13467, Reforming Processes Related to Suitability for Government Employment, Fitness for Contractor Employees, and Eligibility for Access to Classified National Security Information, as amended; EO 13549, Classified National Security Program for State Local, Tribal, and Private Sector Entities; EO 13587, Structural Reforms To Improve the Security of Classified Networks and the Responsible Sharing and Safeguarding of Classified Information; Security Executive Agent Directive 3, Reporting Requirements for Personnel with Access to Classified Information or Who Hold a Sensitive Position; and Security Executive Agent Directive 6, Continuous Evaluation.

**Purpose:** This information is collected to meet reporting requirements regarding foreign travel for federal employees with sensitive positions and access to classified information. Further the information will be maintained in records that may be used to provide investigatory information for determinations concerning whether an individual is: suitable or fit for Government employment; eligible for logical and physical access to federally controlled facilities and information systems; eligible to hold sensitive positions (including but not limited to eligibility for access to classified information); fit to perform work for or on behalf of the Government as a contractor employee; qualified for government service; qualified to perform contractual services for the government; and loyal to the United States. The information may also be used to document such determinations.

**Routine Uses:** The information will be used to maintain foreign travel records which are considered foreign activities. In addition to those disclosures generally permitted under 5 U.S.C. 552a(b) of the Privacy Act, all or a portion of the records of information contained in this system may be disclosed outside USDA as a routine use pursuant to 5 U.S.C. 552a(b)(3).
