## Utah Shrubland Studies Field Tour Rehabilitation of big sagebrush sites in northern Utah June 25, 2015

On June 25, the Utah Section Society of Range Management annual summer tour visited one of the research and demonstration areas established in 2013 through a collaborative research effort.

Approximately 25 people in attendance, including presenters.

The field tour commenced with the Utah Shrub Management Group, whose research is focused on understanding how Ecological Sites can inform management decision making and broaden understanding of management outcomes on Utah rangelands. Dr. Kari Veblen (P.I., Utah State University) introduced the history and scope of the group's research, including project participants: USU, USDA-ARS, NRCS, UGIP, DuPont, and the land owners, Monty and Diane Weston. Justin Williams (USDA-ARS) explained the research design at the Bear Lake Study site, and the target shrub, Wyoming big sagebrush (Artemisia tridentata ssp. wyomingensis). Rebecca Mann (Utah State University), discussed the soil and ecological characteristics associated with the study site. Tour participants were able to examine first-year results of 5 shrub reduction methods (4 herbicides + mowing), and efficacy of 2 seed mixtures (traditional and improved varieties).

Rebecca Mann, a USU graduate student on the project, providing information on the soil composition at the trial site using a "soil pit" to demonstrate soil texture and content at different soil horizons.
